able to capture New Hampshire's Division III Boys Soccer Championship, thus denying Claremont's Stevens High's attempt to win their first title in 27 years, escaping with a 1-0 triumph.

The game's only goal came with just over 15 minutes remaining in the first half when Hopkinton's Jacob Rockwood, the team's senior midfielder, was able to boot the ball past Stevens junior goaltender Tanner Durkee from out of a scramble in front of the goal.

utes of play.

Because of the early goal Hopkinton, the number five seed, was able to ease up on any offensive threat in second-half play and, instead, concentrated on keeping the ball away from the number two seeded Cardinals.

"We tried to go wide, but they shifted well," reported Stevens coach Jason Stone after the game commenting on Hopkinton's second-half domination. "They did the right thing out there on defense."

The 1-0 setback followed a regular season ending 6-0 trouncing in Claremont by the same Hopkinton squad, Stevens' only loss other than a first-game defeat. In between, the Red-

birds were unbeatable and finished the 2016 season, including playoff games, with a polished 17-3 record.

"I knew we weren't 6-0 worse against them," Stone pointed out. "We certainly used that for some motivation. This almost went our way here today. What? The

ball bounced twice and then finally someone put the ball in the back of the net." he said in reference to the gamewinning boot. "We were all over them in the first half. We were trying to expose the right spots. We were confident if we could only get the ball upfield. We did a pretty good job of taking the ball away from them, I thought!"

only two boys soccer championships, in 1976 and 1989, while Hopkinton has now captured titles in two of the last four years.


"Everybody doubted us because we had a soft schedule," Stone stated. "But, look, it's working. It's going to be the same next year, just flip-flopped," he went on, meaning home and away games. "We did everything we wanted to do. That last loss motivated us to get into the playoffs. It stung a little bit. We won all the games we were supposed to and maybe won some we weren't. We did beat Kearsarge and Fall Mountain twice. This is not a total loss for sure. We can have confidence now to get back here (the finals)."



"I know the guys are hurting right now," the (Continued on page B3)





On To Semi-Finals For Stevens Football Team

The Stevens football team earned the 3rd seed in the North Conference of Division III and a Quarterfinal matchup with the Campbell Cougars, who earned the 2nd seed in the South Conference. Since Stevens earned 96 points on the year to 94 points for Campbell, the Cardinals were awarded a 7PM home

game.

The Cardinals did not want to disappoint the home crowd and wasted little time in getting on the scoreboard as they took the opening kick-off and marched 71 yards, capping the drive on a toss to Richard Bell for a 20 yard touchdown. The conversion failed but Stevens was up 6-0.

Stevens marched 89 yards for a touchdown on their second possession. The drive culminated on a 26 yard strike from Henri Bourque to Parker Smith for the touchdown. Bell ran in the conversion and it was 14-0. On their next possession, the Cardinals struck again immediately. The 78 yard drive took a single play, as Bell took the toss and stopped to throw a perfect strike to Smith, for a 78 yard touchdown. The conversion failed but Stevens ended the first quarter up 20-0. Defense was the story of the second quarter as neither team would dent the scoreboard and it remained 20-0 at the break.

The Cardinals had the only score in the third quarter as Smith would score his third touchdown of the game hauling in a 41 yard pass from Bourque and went in untouched. The conversion would be no good but Stevens was in control 26-0, after three quarters of play.

The game's final score came in the fourth quarter on a 4th down scramble by Bourque, who would dive in from 5 yards out for the

touchdown. Stevens failed for the 4th time to tally the conversion and the 32 points would give them the 32-0 victory.

Smith had a big evening as he caught 5 passes for 207 yards and 3 touchdowns. Bell rushed for 156 yards on 17 rushes, and a touchdown, and also threw the 78 yard touchdown pass. Bourque completed 15 of 18 passes for 213 yards and a pair of touchdowns. The offensive and defensive line of Aidan Cahill, Brendan Bean, Joe Desilets, Tim Heighes, Chris LaFont, Nick O'Brien and Nick Stone controlled the line of scrimmage on both sides of the ball, opening holes all evening for the Stevens running backs, while closing down any lanes for Campbell.

Stevens advanced to the final four of the NHIAA Division III playoffs, and will be action on Saturday afternoon, as they will travel to West Swanzey to take on the undefeated, #1 seeded, Monadnock Huskies, with a trip to the Division III Championship Game on the line. Game time is 1PM.

Cullison Performs On And Off Field

SHAWNEE, OK--Caitlin Cullison, a goalie on the Oklahoma Baptist Women's Lacrosse team, knows how to act on the lacrosse field, and off.

A senior interdisciplinary major, Cullison chose to study theatre as part of her three focuses. Most of her days this semester have so far been spent in classes, lacrosse practice, and rehearsals for her role in the upcoming play "You Can't Take it With You."

"It's interesting," Cullison said. "Right now, Coach [Beech] is really good about letting me get out of practice early sometimes or letting me miss a couple practices because we're in the off-season."

Originally from Lempster, NH, Cullison said she always knew she wanted to go to OBU.

fered scholarship didn't hurt either, she said. "I was already basically set on OBU anyway, and it was really helpful to have the scholarship so I was like, 'Yeah, let's play lacrosse,'" she said.

To help manage her busy schedule and workload Cullison said she gets up early in the mornings to

"You get a lot of sleep, you've got to get up really early to do homework, and maybe eat some food once in a while," Cullison explained. "Sometimes it's really stressful but it's worth it because you get really good bonds with your teammates and really good bonds with the crazy theatre people, who I love."

Currently Cullison is playing the role of Reba, the maid, in the OBU theatre's production of "You Can't Take it With You." While Cullison said some days can be as busy as going to class, going to practice, and going to rehearsal all in row, it's all been a good experience so far.

"Reba and I have a lot in common, we both live with a bunch of crazy people," Cullison joked. "But this play's a lot of fun, I'm really excited to do it."

With a busy lacrosse season coming up next semester, Cullison said this may be her last play to be a part of. A fact that she said, does make her feel a little sad.

"This might be my last play at OBU and I'm really sad about that, because there's going to be some amazing things going on next semester," she lamented.

Going into her last lacrosse season Cullison said she hopes to make it through the season injury-free.

"I've been hurt every year since freshmen year, something has been wrong with me," she said. "So it would be nice to have a slightly injury-free season."

After graduation Cullison said she hopes to use her interdisciplinary degrees in Theatre, Digital Media Arts, and English to pursue a career in either cinematography or with National Geographic. Cullison said she feels her acting experience could be a huge help to her, especially in cinematography.

"I think it will help me understand, especially if we were doing something scripted," she said. "I could better understand the actor's perspective and better put into words what I wanted them to do in terms that they could understand."

More importantly, Cullison said, she just wants to be happy. Being happy, she said was part of her decision to study theatre. Cullison had started to become more interested in theatre her junior year of high school and decided to make it part of her career.

"I really got into it my junior year of high school and kind of figured that I was good at it and something that I liked doing and that was my goal for the rest of my life, to just be happy and be able to do something that I like to do."







Mr. Goggin worked as a chemist for the Nashua Corporation and a computer operator/programmer for Sanders Associates, both in Nashua; a computer programmer for Miniature Precision Bearing Company in Keene; a metallurgical technician at Joy Manufacturing Company and for Coca-Cola Company in Nashua writing a training manual on sanitizing procedures for beverage processing equipment.

In November 1983 he joined the U.S. Postal Service as a letter carrier in the Claremont Post Office, where his father had worked for 51 years. He concluded his service working as the custodian for the Newport Post Office. He retired on April 30, 2016 after 33 years with the Post Office.

He enjoyed reading stories to his children and later his grandchildren. He enjoyed chess and climbing Mount Ascutney in Vermont, rising at 4:30 a.m. several times a week to climb the mountain before going to work. His photo-

graphs of the mountain were published in the Eagle Times and displayed at Mount Ascutney State Park.

He married Gloria Haines Goggin December 28, 1968. Besides his wife, he leaves his sons, William Haines Goggin, and his wife, Sharon Stone Goggin, of Claremont, and Timothy Aaron Goggin and his wife, Ashley Just Goggin, of Laconia; his grandchildren

Liam Haines Goggin, Patrick James Goggin, and Harper Laine Goggin of Laconia; sisters Eleanor Goggin Isenburg of Rockville, Md. and Andrienne Goggin Clark of Fitchburg, Ma.; brothers-in-law Adair Gary Haines of Concord; David John Haines of Norwich, Vt. and Mark Allen Haines of Buckfield, Maine; several nieces, nephews and cousins.
