

## Big Green Finish Season Ranked 9th in Final IWLCA Coaches Poll

HANOVER, NH—The Dartmouth women's lacrosse team will finish the shortened 2020 season ranked ninth in the final Intercollegiate Women's Lacrosse Coaches Association (IWLCA) national poll released on Thursday.

The Big Green — like every other team in the nation — had its 2020 campaign cut short to limit the amount of exposure to the COVID-19 virus. In the five games played this spring, Dartmouth was a perfect 5-0.

With wins against No. 13 UMass and No. 5 Florida in addition to dominating wins against Boston University and New Hampshire, as well as an overtime thriller against Brown in the only Ivy League game of the season, the Green and White were rewarded with a spot in the top-10 in the final release of the year.

It marks the first time finishing in the top 10 in the final poll since 2012 when Dartmouth was 10th, its highest finish since the poll began in 2009.

Though final rankings were not released by the US Lacrosse Magazine and Inside Lacrosse, the Big Green were No. 6 and No. 7, respectively, in the most recent releases of each poll.

In all three, Dartmouth was the highest-ranked Ivy team.

## Reading Challenge Extended through April 13

### *Fisher Cats Reward at-Home Learning During Social Distancing*

MANCHESTER, NH—As families across New England practice social distancing, the New Hampshire Fisher Cats (Blue Jays Double-A affiliate) are pleased to offer a rewarding way for students to continue learning at home: the extension of the Reading Challenge program through April 13.

Thanks to support from Eversource, students who read five books outside of their school curriculum will earn two free tickets to a Fisher Cats game in 2020. At their chosen game, those students will be recognized for their achievements and get to play catch on the field.

To kick off the extended Reading Challenge, Fisher Cats emcee Zick and mascot Fungo hosted a reading session via Facebook Live on Thursday, March 19. Similar to their annual visits to over 30 schools in New Hampshire and northern Massachusetts, Zick and Fungo read "The Lorax" by Dr. Seuss and shared their passion for reading.

"As we follow the guidance of our local and federal officials to practice social distancing, this is a perfect opportunity to reward students for continuing their education from home," said Fisher Cats President Mike Ramshaw. "We're proud to partner with Eversource and extend the Reading Challenge deadline to April 13, and we look forward to recognizing these students at the ballpark as soon as possible!"

Since the program's inception in 2007, nearly 600,000 students have been reached and over 3 million books have been read.

Schools also have an incentive to encourage their students to complete the challenge. Schools with the highest student participation will share a \$5,000 cash prize made possible by Eversource and the Fisher Cats Foundation. This year's prize will raise the total to \$50,000 awarded through the reading program since 2011.

## Get Outside and Report Your Wild Turkey Sightings Through March 31

CONCORD, NH — The New Hampshire Fish and Game Department encourages wildlife watchers to explore their backyards, fields,

and woodlands and report sightings of wild turkeys. The Department's Wild Turkey Flock Survey is open through March 31. The public is asked to report turkey sightings online at [www.wildnh.com/surveys/turkey.html](http://www.wildnh.com/surveys/turkey.html). Please do not report multiple sightings of the same flock.

Last winter, volunteer turkey watchers submitted 486 flock reports, totaling 9,833 turkeys. Reports were down last year from the previous year's totals likely due to the high mobility of turkeys throughout winter. Much of the state experienced relatively low snow fall with icy crusts, which allowed turkeys to move easily without burning energy stores. This also resulted in turkeys not having to congregate for long periods in sites where they would be continually observed, according to Fish and Game Wildlife Programs Supervisor Dan Bergeron.

The purpose of this online survey is to enhance the New Hampshire Fish and Game Department's existing winter flock data collection efforts, adding to the Department's understanding of the abundance and distribution of turkeys during New Hampshire's challenging winter months. This is also an exciting way for citizen scientists and students to interact with their local turkey populations.

The digital survey asks participants to report the number of turkeys in the flock, where they were seen, the type of habitat the birds were observed in, and what the turkeys were feeding on (acorns, beechnuts, birdseed, corn silage, etc.).

"This reporting system allows the public to contribute important information to our understanding of winter turkey status in an inexpensive, efficient and, hopefully, fun and educational way," said Bergeron.

The Department is also asking observers to report any signs of two viruses that have appeared in New Hampshire's turkeys in recent years. "The viruses are not too widespread yet, but we are keeping a close watch," said Bergeron. "Look for warty protuberances in the head and eye area."

Knowledge of the status of wintering wild turkeys is particularly important in New Hampshire, where severe winter weather and limited natural food supplies can present serious challenges for turkeys.

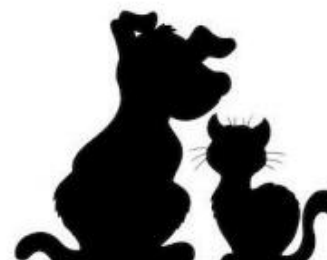

Darrell joined the Army in 1953 and very proudly served with The Big Red One Infantry Division. He was stationed in several places including Texas and Germany and loved to share pictures and stories with family and friends. After the Army, Darrell moved to Claremont and made that his home, in 1957 he started work at the Claremont Post Office as a mail carrier. He loved working for the Post Office and thirty-one years later he retired as Postmaster. When his wife refused to let him sit home and do nothing, he went to work part time at the Claremont Police Station with parking enforcement for a few years.

On December 31, 1960 he decided to join a friend at a New Year's Eve party and that is where he met the love of his life, Bev Cady. They married 10 months later on October 28, 1961, and shared 40 wonderful years as the absolute best couple anyone could meet. Together they raised their three children and enjoyed a happy, loving life on Byrd Ave. They both worked hard and devoted their lives to each other and their children.
